

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://foodoo.ai> and IP Holdings, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to IP Holdings, LLC include <https://foodoo.ai>. The IP Holdings, LLC website is a HaaS platform site. Collection of your Personal Information

In order to better provide you with products and services offered on our Site, IP Holdings, LLC may collect personally identifiable information, such as your:
